F. COMMITTEE BUSINESS

F.2. Police Risk Management Committee (PRMC)

F.2.a. PRMC Update

Mr. Tom Kline indicated that trainings are held at each Police Risk Management Committee (PRMC) meetings. Topics recently covered were: Lexipol and Legal Update at the November 2, 2017 meeting; and Below 100 - A Common Sense Approach to Officer Safety at the February 1, 2018 meeting. Mr. Kline noted that there are twelve bills pending that were introduced in the California Legislature 2018-2019 Regular Session that affect the police agencies.

Discussion ensued on De-Escalation issues in recent events and the lack of training for police officers on 5150 process and procedure from their standard training requirement. The consensus of the Committee is to provide supplemental trainings for police agencies on Crisis Intervention and De-Escalation via Regional Training forum to ensure sufficient trainings are provided to members. Chair Ehrenstrom suggested to offer a webinar option to accommodate officers' already busy schedule.

Mr. Marcus Beverly indicated that Lexipol is conducting a De-Escalation webinar on May 10, 2018 and reminded members to encourage their police officers to participate. The webinar is free to NCCSIF members.

F.2.b. PRM Grant Fund Usage Report

Mr. Beverly reviewed the historical grant usage report and noted that most agencies are using the grant for body-worn cameras (BWC) but few have not taken advantage of the grants: Galt has not used any funds so far but is working to implement a BWC program with Council approval; Willows recently outsourced their police department, but plans to remain in the program to fund their Lexipol Fire Policy Service annual fee; Jackson plans to use the funds for BWCs but has yet to request; and Anderson is taking a wait and see approach as management feels the drawbacks outweigh the benefits.

F.3. RM-16 Special Event Risk Management

Mr. Beverly indicated that the Special Events Best Practices were presented to the Board at their meeting on December 14, 2017. The Board requested a change in the last recommendation to obtain waivers from participants only for City-sponsored events and concern about the ability for members to obtain a traffic management plan approved by a qualified engineer. Mr. Beverly noted



that legal counsel revealed that review and approval from someone other than a qualified engineer will not provide the design immunity sought for the plan.

The Committee had significant discussion on what criteria is required on traffic control plan and whether it applies to city sponsored event only or any event in the city. Traffic control plan applies to any events requiring road closure. Members were referred to California Manual on Uniform Traffic Control Devices handbook on Caltrans website and Manual on Uniform Traffic Control Devices for Streets and Highways on the U.S. Department of Transportation Federal Administration website for reference. Mr. Beverly reminded members that city should have a hold harmless language when issuing permits and insurance requirements naming the city as additional insured on vendors holding event at any city properties including streets, sidewalks, etc. Mr. Beverly asked members for a consulting engineer that they would recommend and will share the contact information to the rest of the members.

F.4. FY 18/19 Risk Control Services Plan and Budget

Mr. Beverly presented the Risk Control Services Budget and noted it is the same items as last year. The Lexipol Policy Manual and Daily Training Bulletin (DTB) services increased by 8% to provide DTBs for all members. Mr. Beverly indicated each member is allocated \$4,000 for Member Training and Risk Management fund for conferences and trainings. This is a use-it-or-lose-it and must be used within the fiscal year. Mr. Beverly made an exception for the current year unexpended fund to be used to pre-register to CAJPA (California Association of Joint Powers Authorities) annual conference in September 2018, CalPELRA (California Public Employers Labor Relations Association) annual conference in December 2018 or any risk management related trainings. The training fund is applicable to the CSMFO (California Society of Municipal Finance Officers) annual conference.

F.5. Round Table Discussion

Mr. Jim Ramsey brought up the carbon monoxide leaks with the Ford Explorer including some Police Interceptor model issue. There is no definitive conclusion whether the carbon monoxide leak is a manufacturer defect or as a result from after-market installation of police equipment. This is a potential police safety issue and some members installed off-the-shelf Carbon Monoxide system for precautionary measures.

Ms. Zeigler reported that the very first Risk Management for Supervisors and Managers Training was held with the City of Folsom last week. Ms. Kris Haile stated that the training was very well received and participants came out of the training with keen awareness that risk management is everyone's responsibility.

BICKMORE RISK MANAGEMENT ASSESSMENTS AND SERVICES

INFORMATION ITEM

ISSUE: Gail Zeigler will present an update on the services Bickmore Risk Control has provided NCCSIF members during FY 17/18 and FY 18/19 to date.

Hazard & Safety Assessment

As of September 2018, Bickmore has met with all NCCSIF members and completed the FY 17/18 Hazard & Safety Assessments. Discussions included progress made on the prior year's recommendations and assessing members on the two new categories, Volunteer Risk Management and Special Events Risk Management.

Member Services

Members receive two days of risk control services to help implement recommendations from the Hazard & Safety Assessment. Examples of service include written program development for Cal/OSHA compliance and liability exposures, assistance with program implementation, participation in safety committee meetings, inspections and customized employee training. One additional day of service is provided to each member for additional requested services such as ergonomic evaluations, playground inspections program development, etc.

Members can also receive a half day on-site risk management orientation (Risk Management 101 for Managers and Supervisors). This orientation is jointly led by the NCCSIF Program Administrator, York Account Manager (TPA) and Bickmore Risk Control Account Manager. The cities of Folsom and Oroville have participated in the orientation. Several other members have indicated a desire to schedule the orientation at a future date and time. Bickmore will continue to reach out and schedule additional trainings at member cities request.

Regional Training Workshops:

Bickmore has scheduled and provided the following regional trainings since the committee last met in April 2018:

- Aquatics Risk Management
 - Yuba City: May 16, 2018; 14 attendees
- Commercial Driver Safety
 - Red Bluff: June 12, 2018; 25 attendees
 - Rocklin: June 13, 2018; 40 attendees
- Traffic Control & Flagger Training
 - Corning: July 10, 2018; 35 attendees
 - Dixon: July 11, 2018; 41 attendees



RISK MANAGEMENT FRAMEWORK

1

- **1-1** Executive Management has developed a Risk Management Policy that supports an effective risk management structure designed to protect employees and reduce costs associated with liability and workers' compensation losses.
- 1-2 The City Council has adopted a resolution supporting the Risk Management Policy.
- **1-3** The NCCSIF Board and Risk Management Committee members have reviewed the updated NCCSIF Risk Management Policies & Procedures Manual.
- 1-4 A Safety/Risk Management Committee has been formed to assist with effectively implementing the City's Injury & Illness Prevention program and risk management program. The committee provides regular progress reports to Senior Management.
- **1-5** The City conducts an analysis of liability and workers' compensation losses to identify trends and loss reduction measures.
- **1-6** A risk control plan is developed with measurable loss reduction goals.
- **1-7** A system is in place to immediately report and investigate workers' compensation and liability claims to control claims costs.
- **1-8** Return-To-Work program is in place to aid in employee recovery and reduce claim costs.
- **1-9** The City utilizes the available NCCSIF risk management and safety resources.

5 ERGONOMIC INJURY MANAGEMENT

- 5-1 The City has developed an ergonomics program to assist in the identification, prevention, and control of exposure to ergonomic risk factors (awkward postures, repetitive motion, forceful exertion, contact stress, and vibration). https://www.dir.ca.gov/title8/5110.html
- **5-2** High risk positions are identified by utilizing worksite evaluations, job hazard analyses, employee input, and loss data.
- **5-3** Once the risk factors are identified the City works at developing controls measures.
- **5-4** A system is in place for employees to report discomfort and/or symptoms of musculoskeletal problems and for the City to identify ergonomic solutions.
- 5-5 All employees are trained to recognize work-related ergonomic risk factors. High-risk employees are trained on their specific ergonomic risk factors and control measures.

6 SIDEWALK LIABILITY MANAGEMENT

- **6-1** Written sidewalk inspection and mitigation procedures are in place. Procedures include a schedule for routine, documented sidewalk inspection and repair.
- 6-2 A written process is in place to notify property owners to repair sidewalks as allowed by the Municipal Code.
- **6-3** Follow-up procedures are in place to ensure defects have been mitigated by the property owner within a reasonable period.

- 6-5 Photographs are taken and maintained to visually record action taken to guard against contact by the public within a hazardous sidewalk site.
- 6-6 The City maintains, where feasible, an annual budget to administer the program.
- **6-7** A sidewalk liability transfer ordinance has been adopted. Alternatively, the City Council has considered and declined to pass such an ordinance.

7 URBAN FOREST MANAGEMENT

- 7-1 The City has a written urban forest management plan that includes selection and placement of trees and provides for identification and mitigation of hazards related to trees, shrubs, and vegetation. The plan also includes procedures for periodic inspection, care, maintenance, and complaint/emergency response.
- **7-2** Urban forest management is under the control and supervision of persons who have the expertise to qualify as urban foresters or arborists. Alternatively, the management plan was created by an expert and managed by the City.
- 7-3 Inspection and monitoring frequency is prioritized by degree of exposure of the public to vegetation hazards. (i.e.: obscured intersections, parks, playgrounds).
- **7-4** The City examines and, where feasible, budgets for the cost of tree maintenance, including trimming, removal and replacement as needed.
- 7-5 The City has adopted an ordinance defining ownership and maintenance responsibilities for trees.

VOLUNTEER RISK MANAGEMENT

8

- **8-1** The City has either 1) adopted a resolution extending Workers' Compensation benefits to volunteers or 2) the City Council has considered and declined to extend benefits.
- **8-2** Volunteers complete applications and undergo screening procedures. Volunteer screen includes criminal background checks if the volunteer works with children, the elderly or disabled.
- **8-3** Volunteers receive clear direction on the scope of their volunteering duties including a written orientation and training procedures.
- **8-4** The driving records of volunteers who operate vehicles while volunteering for the City are screened and have no more than four points in the last three years.
- **8-5** Volunteers who operate personal vehicles while volunteering for the City must provide proof of adequate auto insurance (NCCSIF recommended minimum limits of: 100k/300k/50k)
- 8-6 Volunteers are advised their own insurance is primary in the event of an accident.
- **8-7** Volunteers working with children have been trained regarding requirements for mandatory reporting of suspected abuse or neglect.

SPECIAL EVENTS

9

- The City has 1) a written process and 2) an application form for applicants who wish to use city facilities and/or host events on public property. (ex: classes, meetings, banquets, outdoor markets, block parties and parades)
- 9-2 The City requires a written contract and/or permit that includes language that the applicant agrees to defend, indemnify and hold harmless the city, its officials, agents and employees from any and all claims arising from the special event.
- **9-3** When appropriate, the City requires the applicant to provide proof of insurance including an additional insured endorsement in favor of the city, its officials, agents and employees for any covered claims arising from the event.
- **9-4** The City utilizes NCCSIF's recommended insurance specifications and requires liability limits of at least \$1 million per occurrence, increasing with the level of risk, with at least \$5 million dedicated limit for any fireworks display or demonstration.
- **9-5** Special events requiring road closures includes a traffic management plan that is approved by a qualified engineer.
- The participants and/or volunteers of special events that involve risk of injury (ex: sporting activities) are required to sign waivers prior to participation.


VSM Program

...It's More Than On-line Training

The Virtual Safety Manager (VSM) Program is a valuable tool that provides agencies with a grouping of resources to facilitate and administer a robust training program.

The VSM Program utilizes a variety of Bickmore safety training resources, Target Solutions (TS) web-based courses, and the TS learning management system. Bickmore staff partners with agencies to:

- Identify Cal/OSHA training requirements for all employees
- Assign training to employees throughout the year based on the agency's desired frequency
- Maintain the LMS, which includes documenting:
 - Assigned training
 - On-the-job and class room training
 - Program and policy employee acknowledgements
- Provide management status and progress reports



Administration & Support

- Bickmore provides ongoing customer service and support for both employees and management
- Detailed management reports are developed on a monthly basis and/or as requested by the agency



Program Set-Up

- Meet with agency leadership to provide an overview of the program and to discuss the direct benefits to the agency.
- Work with Target Solutions to develop the agency's customized TS website.
- Employee data will be collected and entered into the TS Learning Management System (LMS) on behalf of the agency.
- Employee job classifications and workplace exposures will be obtained to assist with identifying Cal/OSHA training requirements.
- Training courses will be selected for the year based on the agency's desired training frequency. An annual training calendar will be provided.

Training

- An orientation will be conducted for managers and employees (On-line meetings, webinars, in-person).
- Managers will also be trained on the additional tracking features available and how they can be integrated into the VSM program:
 - Document on-site training (tailgate talks, on-the-job training, etc.)
 - Document employee program and policy acknowledgements
- Ongoing training will be conducted for new employees and managers

POLICE RISK MANAGEMENT COMMITTEE UPDATE

INFORMATION ITEM

ISSUE: Bickmore Risk Services will provide an update on the recent and planned activities of the Police Risk Management Committee (PRMC).

The PRMC meetings are well attended. At each PRMC meeting a new training topic is covered. For example, the May 2, 2018 meeting covered the *Skelly Process, Peace Officer Bill of Rights, and Brady Obligations* presented by John Whitefleet, from the law firm of Porter Scott.

At the August 2, 2018 PRMC meeting the training topics were *Use of Force, ADA - Application for Arrests and Department Policies and Training* by Bruce Kilday, Kevin Dehoff and Derick Konz, from the law firm of Angelo, Kilday, and Kilduff.

For the November 1, 2018, PRMC meeting, the topics include a demonstration of StarChase Pursuit Management Technology by the California Highway Patrol. The technology allows police to "tag" a fleeing vehicle, avoiding potentially dangerous pursuits. In addition, Derick Konz, from Angelo, Kilday and Kilduff, will discuss new laws affecting the police, including requirements for disclosure of videos and personnel records that are sure to generate more Public Record Act requests (see attached).

Planned for the February 21, 2019 PRMC meeting, Laura Cole, from Cole Pro Media, will provide training on social media and crisis management.

As part of the roundtable portion of the meeting, potential training topics, legislation, and new case law that impact law enforcement agencies are reviewed. Workers' compensation and liability claim trends and "lessons learned" from recent claims are also on the meeting agenda.

FISCAL IMPACT: None.

RECOMMENDATION: None - information only.

BACKGROUND: NCCSIF contracted with Bickmore Risk Services (BRS) on January 1, 2012 to provide risk control services. Contracted services include the facilitation of the Police Risk Management Committee meetings, primarily by Tom Kline of BRS.

Certain Police Personnel Records No Longer Confidential

New California Law Increases Access to Records Under PRA



Local agencies in California will be required to provide increased access to peace and custodial officer personnel records with the passage of SB 1421, signed by Gov. Jerry Brown. The new law makes officer personnel records that were previously confidential available to

the public pursuant to a California Public Records Act request.

This legislation, signed Sept. 30, follows years of public outcry against police conduct in officer-involved shootings and increased advocacy for transparency in policing. California affords police officers some of the strictest privacy protections in the nation with respect to personnel records. SB 1421 loosens these protections.

Existing law provides that requests for information in police personnel files and records of citizen complaints must be made through a *Pitchess* motion in compliance with stringent statutory procedures. SB 1421 now makes some of these records available in response to a PRA request, including:

- Reports, investigations and findings related to an incident involving an officer's discharge of a weapon or use of force resulting in death or great bodily injury.
- Any record related to an incident in which sustained findings were made that an officer engaged in sexual assault against a member of the public.
- Any record related to an incident in which sustained findings were made that an officer was dishonest in the reporting, investigation or prosecution of a crime or the reporting or investigation of another peace officer.

SB 1421 also defines the types of records that must be disclosed in these instances, including:

- All investigative reports, photographic, audio and video evidence, transcripts or recordings of interviews, and autopsy reports.
- · All materials compiled and presented for review to the district attorney or

anyone else charged with determining whether to file criminal charges against an officer or a course of disciplinary action.

- Documents setting forth findings or recommended findings.
- · Copies of disciplinary records relating to the incident.

An agency may withhold or delay disclosure of these records if they concern incidents that are the subject of an active investigation. Among the limited reasons for which records may be redacted are if "there is a specific, articulable, and particularized reason to believe that disclosure" would pose a significant danger to the physical safety of the peace officer or another person.

Though the impact of SB 1421 on agencies' handling of police personnel records and investigations of complaints is still being assessed, local agencies should prepare for increased demand for records disclosures.

AB 748: More Public Access to Body Camera Footage Under PRA

Amendment to California Law Gives Public Agencies More Responsibility to Provide Footage



The California public will have a greater right to access police body camera footage, and any other audio or video recording acquired by any police agency or state prosecution office, under the Public Records Act with the passage of Assembly Bill 748. The law mandates

that audio and visual recordings of "critical incidents" resulting in either the discharge of a firearm by law enforcement or in death or great bodily injury to a person from the use of force by law enforcement are to be made publicly available under the PRA within 45 days of the incident, with limited exceptions. Approved by Gov. Jerry Brown late last month, AB 748 goes into effect July 1.

Under existing law, the public is entitled to certain information contained within complaints and investigations of crimes, although public agencies may otherwise withhold material that would endanger either the success of an ongoing criminal investigation or the safety of people involved in that investigation. Under AB 748, recordings acquired by law enforcement and prosecutors must generally be disclosed in response to a PRA request within 45 days of the "critical incident" or the date the public agency reasonably should have known it occurred.

A public agency may delay disclosure of the recording for between 45 days and 1 year during an active criminal or administrative investigation, but only if disclosure would "substantially interfere" with that ongoing investigation.

Examples of such interference include endangering a witness' or confidential source's safety. After 1 year following the critical incident, a public agency may withhold the audio or visual recording only if the agency demonstrates, by clear and convincing evidence, that disclosure would still substantially interfere with an ongoing investigation. Under AB 748, the public agency is required to reassess the withholding of that recording and notify the PRA requester every 30 days. Any time a public agency withholds a recording on that criteria, the requester must be notified in writing.

Once the specific basis for withholding the recording of a critical incident is resolved, it must be disclosed. However, if a public agency demonstrates that the reasonable expectation of privacy for individuals depicted in the recording outweighs the public's interest in disclosure, the public agency must use "redaction technology, including blurring or distorting images or audio" to protect those privacy interests prior to that recording's disclosure. If the public agency demonstrates that the reasonable expectation of privacy cannot be adequately protected by redaction, the public agency may withhold the recording. However, a redacted or unredacted copy of that recording must be made promptly available to any person (or designated representative) whose privacy interest is protected by public nondisclosure. AB 748 does not apply to peace officers employed by the California Department of Corrections and Rehabilitation.

SAFETY AND RISK CONTROL SERVICES AGREEMENT WITH BICKMORE RISK SERVICES

ACTION ITEM

ISSUE: The Committee is presented a draft Scope of Services for a new contract with Bickmore Risk Services, effective July 1, 2019. The Program Administrators met with Bickmore representatives to provide feedback regarding the scope and potential changes to the Agreement. Bickmore has provided the attached *draft* Scope of Services for review and discussion. Also attached is a summary of the changes in the proposed and current contract services.

The proposed service rate remains the same at \$155 per hour. The total cost for up to four days of service time per member has decreased by (-\$6,380), with the cost for the assessment and action plan day increasing by \$10,780 and the cost of the three service days decreasing by (-\$17,160). The fee for meeting preparation and participation has increased by \$2,800, approximately 18 hours.

Phone and email consultation has increased from 10.25 hours to approximately 12 hours (1.5 service days) per month. Safety communication is increasing by 12 hours per year and training coordination by 24 hours. The increased hours in a number of categories offset the savings noted above to result in a total increase of \$5,260 (3%) for approximately the same services as currently provided.

In addition, Bickmore added a new category for Workers' Compensation review and consultation based on feedback from the Program Administrator. The suggestion is for Bickmore to provide more immediate oversight of claims to look for incidents that deserve further root cause analysis and/or corrective action, including changing procedures, equipment, and/or ergonomic conditions. For those claims involving temporary disability the review may include comparison to agreed-upon best practices and resources as needed to develop temporary assignments and get people back to work.

OPTIONS:

- 1. Recommend as presented
- 2. Recommend as amended with a different mix/type of services
- 3. Provide further direction to Program Administrators prior to EC recommendation

RECOMMENDATION: Review and provide recommendations to the Executive Committee.

FISCAL IMPACT: TBD - the new suggested service is estimated at 14 service days for a total of \$17,360. If included the total annual fee would be \$199,340, or \$22,620 (13%) more than the current contract. If the new service is not included the total is \$181,980 annually, an increase of 3% from the current annual fee of \$176,720. Note the fee and hours are the same for each of the proposed five years.

BACKGROUND: NCCSIF contracted with Bickmore on January 1, 2012 to provide risk control services. Bickmore's contract for risk management services expires June 30, 2019, and this is an opportunity for members to assess the value and mix of services provided since the current contract and scope of services was established in 2016.

The Board has agreed with the Executive Committee's recommendation to negotiate a new agreement with Bickmore with a three-year term and two optional years, beginning July 1, 2019.

Exhibit A

SCOPE OF SERVICES

Services will be coordinated with the NCCSIF Risk Management Committee, and at its direction, annual services will include:

Focused Risk Assessments/Action Plan - \$27,280 (22 members, one service day/member @ \$1,240/service day)

Conduct a focused risk assessment for each member including discussion on member's specific needs, develop action plans and review the available risk control resources. Maintain and update the member's progress and scorecard throughout the year.

Member Services - \$81,840 (22 members, 3 service days/member @ \$1,240/service day)

Provide the equivalent of three days (provided in half day and/or full day increments) of risk management and risk control services to each member, facilitate Risk Management 101 for Supervisors and Managers, and, provide risk control services orientations to new risk management committee members. Risk management and risk control services may include assisting with best practice recommendations identified in the risk assessments, providing on-site training, participating/facilitating in committee meetings, ergonomic evaluations, developing written programs/policies, inspecting facilities and other consulting services.

NCCSIF Meetings - \$24,500 (7 meetings/year @ flat rate \$3,500/meeting)

At least one Bickmore staff will prepare, attend and participate in the meetings which may include:

- Risk Management Committee
- Police Risk Management Committee
- Executive Committee (when CLIENT requested)
- Board of Directors meeting (when CLIENT requested)

Pricing includes staff time for staff report development, analysis/research of topics, training coordination, agenda preparation, meeting attendance, travel time, and expenses.

Phone and Email Consultation - \$22,320 (1.5 service days/month @ \$1,240/service day)

Provide members with unlimited access to a risk control professional for technical information and guidance. This service provides one central resource to help answer questions about occupational safety and health, risk management and CLIENT best practices.

Safety Communication/Resource Development - \$7,440 (6 service days @ \$1,240/service day)

Timely safety topic information will be provided to NCCSIF members on a regular basis. In addition the Bickmore website will be updated regularly, and links will be provided in the safety communication.

Training Coordination - \$18,600 (15 service days @ \$1,240/service day)

Coordination of member services and eight regional trainings per year (four topics offered in a Northern and Southern member location). Service may include topic research, trainer and location selection, announcements, electronic registration management, materials development, coordination and facilitation of services and/or attendance and participation at training.

Worker's Compensation Loss Data Review and Member Consultation - \$17,360 (14 service days @ \$1,240/service day)

Review monthly WC claim report for frequency and/or severity trends. Contact members as needed to assist with root cause analysis and correction strategies to prevent future occurrences.

Bickmore Risk Control Website Resources - (no additional cost)

Members will have unlimited access to all the resources available on the Bickmore Risk Control website which includes over 300 on-line streaming videos, hundreds of safety training handouts and risk management regulatory publications, recorded safety webinars, sample programs, forms, and checklists. Members will also receive invitations to participate in all live webinars.

Total Cost: \$199,340

COST OF SERVICES

Fee Structure

- 1. All services identified in this agreement will be provided for the not-to-exceed fee of \$199,340.00 annually. This rate includes mileage travel expenses, and value-added services such as access to streaming videos, webinars, and safety communications.
- 2. BICKMORE will invoice CLIENT monthly at a rate of \$16,611.66, with payment due on the last day of the month of service for the life of the Agreement.
- 3. CLIENT will be asked to reimburse BICKMORE for any pre-approved additional expense(s) incurred that are beyond the scope of the Agreement. This will include such things as industrial hygiene lab work and supplies, training materials, refreshments for training attendees, etc.

Additional Services

Additional services consistent with this proposal will be available to CLIENT on a time and materials basis. Fees for such additional services will be negotiated on an as-needed basis.

RETURN TO WORK (RTW) BEST PRACTICES

INFORMATION ITEM

ISSUE: The Program Administrators recommend an increased focus on member Return To Work (RTW) efforts as a means of reducing the overall cost of claims for the group. Offering modified duty to get employees back to work as soon as possible has shown to decrease disability by up to four weeks, with a 5 to 1 return on investment (see reference Resource below).

In addition, having a modified duty program helps members with those employees who suffer disabilities off the job, to transition them back to work or to another occupation through the interactive process, avoiding potential ADA claims in the process.

The attached article provides a good overview of why it's important to have a return to work program and the elements of a best practices program. This is offered as starting point for discussion regarding current member practices and how the pool may best assist members in this important subject. This likely will lead to developing a set of best practices for the group to adopt, similar to those already in place for other risk exposures.

RECOMMENDATION: Review and discuss suggestions for establishing and assisting members in adopting best practices for a Return to Work program.

FISCAL IMPACT: None.

BACKGROUND: NCCSIF maintains a set of Risk Management Best Practices to assist members in identifying and managing a number of their most common risk exposures. NCCSIF regularly reviews the existing policies to keep up to date with legislative changes, case law, and emerging risk exposures to pool members. Currently we are working to update the policies as needed and condensing and customizing the assessment criteria currently in use. The goal is to achieve a unified set of policies and best practices that will provide a framework for member risk management programs and assessments.
