Chief Butler of Rocklin PD shared Senate Bill 978 that will be effective January requiring law enforcement agency to conspicuously post on the web sites all current standards, policies, practices and training materials.

E.2. Workers' Compensation Claims Analysis for Police

Ms. Dori Zumwalt from Sedgwick provided an overview of police departments claim trends over the last five years and analysis of the top loss exposures. It is a downward trend across the board: number of claims, loss days and costs. The City of Elk Grove was inadvertently omitted in the analysis. Ms. Zumwalt indicated that she can customize a report for each agency by request.

Lt. Jeff Scott requested for claims analysis report for the Elk Grove PD.

It was noted the total number of sworn officers for NCCSIF law enforcement agencies for FY 18/19 is 698.

E.3. Technology Discussion

The Committee discussed emerging technologies in policing innovations such as the Bolo Wrap remote restraint that could be used as alternative to Tasers.
