Oram, and Adam Ambrozy from Lenahan, Lee, Slater, Pearse & Majernik, LLP to the Liability Counsel Approved List. The hourly rates for the firm: \$225 for Senior Partners, \$210 for Partners, \$195 for Senior Associates and \$90 for Paralegals. I. NCCSIF FY 17/18 LIABILITY PROGRAM CLAIMS AUDIT

Mr. Beverly stated that Rick Buys was unable to attend due to family emergency. Mr. Beverly reviewed the highlights of the audit and noted overall the results meet or exceed the standard requirements. There were two areas cited for improvement: rejection of claims within 45 days and scene investigation.

Mr. Dewey provided his response to the audit. There is no empirical data to suggest that rejecting claims at 45 days brings increased litigation. Mr. Beverly confirmed that he discussed the areas of concern as suggested in the audit with York.
