### A. CALL TO ORDER

Chief Tod Sockman called the meeting to order at 10:06 a.m.

#### E. RISK MANAGEMENT

### **E.1.** Police Risk Management Grant Funds

Mr. Marcus Beverly indicated that the NCCSIF members have funded grants totaling \$50,000 per year for their police departments to purchase and implement Body-Worn Cameras (BWC) since FY 14/15. Since inception of the police grants, all but four members have taken advantage of the grants and have BWCs in use. The Galt Police Chief is supportive of BWCs but has been unable to obtain political or financial support. Willows recently outsourced their police department but plans to remain in the program to fund their Lexipol Fire Policy Service annual fee. Jackson has BWCs but has yet to request grant funds for them. Anderson is taking a wait and see approach as management feels the drawbacks outweigh the benefits.

Chief Robert Thompson arrived at 10:16 AM.

Mr. Beverly indicated the main purpose of the grant was to fund the BWC and since majority of the agencies have fully funded BWC the grant can be used for general risk management purposes only if the agency has fully-funded BWC program. It was noted the fund is used primarily for body camera and storage. Chief Doug Lee of Lincoln PD asked about the criteria for other use. Mr. Beverly indicated the purpose is to aim in reducing the frequency and severity of claims.

Chief Sockman of Galt PD indicated he would certainly like to use the grants for Cordico Wellness App.

After discussion, the Committee expressed interest in allowing members to use the current grants for the Cordico app or other risk management needs as a way of clearing out the balances of those members who have yet to use the grants and would like for the grant program to continue for next FY 19/20. Some agencies, Dixon and Elk Grove, are already using the Cordico wellness app.

### E.2. Cordico Mobile Wellness Apps for Law Enforcement

Chief John Carli of Vacaville Police Department spoke about his department's experience with Cordico Mobile Wellness Apps for Law Enforcement. The Cordico Wellness Apps provide wellness resources on demand 24/7. The City of Vacaville is the early adopter of Cordico service. Chief Carli circulated two reports on: 1) Final report of The President's Task Force on 21st Century Policing, published in May 2015; and 2) Officers' Physical and Mental Health and Safety Follow up assessment and recommendation report, published in April 2018. Cordico provides expert peer support within the region and on demand site services. This is the future of individualized peer support and HIPPA approved compliance teletherapy.

Lt. Scott of Elk Grove PD mentioned his agency uses Cordico app and recently included Wellness portion for the spouses. Elk Grove PD mandates their officers to see Dr. Black before returning to work. The app is well received by their agency.



Chief Thompson of Dixon PD mentioned his agency also provides Wellness for the spouses and does spousal interview to get them involved in the beginning. The app is well received by their agency.

Chief Carli indicated this is the future of life fitness body and mind approach best practices with family involvement. The cost is unknown due to number of services available and scalable to each agency's needs. After Chief Carli's presentation, a couple of agencies are considering the Cordico Wellness and would like the support of the Board with funding to cut down the cost for each agency to implement at their jurisdiction.

The Committee directed Tom Kline to have Dr. David Black, CEO and Founder of Cordico, present to the group at the next meeting.

### **E.3.** Workers' Compensation Claims Analysis

Ms. Dori Zumwalt from York provided an overview of police department claims analysis for the past five years. The report provided a better understanding of the nature and severity of injuries. The need to implement health and wellness programs were discussed that could help reduce workplace injuries and in turn, keep claims cost down. Ms. Zumwalt indicated that she can customize a report for each agency by request to provide to their respective City Council. Ms. Zumwalt suggested Savvy Fitness as future training topic.

### **E.4.** Technology Discussion

Mr. Kline shared Analytical Patrol Model by Directorate 2 as another resource tool for law enforcement to use intelligence techniques to prevent biased policing.

Chief Butler of Rocklin PD shared a success story of a liability case that has been avoided based on video evidence.

#### **E.5.** Round Table Discussion

Mr. Kline went over the future training topics as follows:

- Dr. David Black, CEO and Founder of Cordico Wellness Apps for Law Enforcement
- Paul Wright, Founder and CEO of Savvy Health Solutions
- 15-minute presentation by San Bruno PD Commander on the Active Shooter Incident at the YouTube Headquarters

Ms. Gail Zeigler mentioned that NCCSIF is scheduled to conduct a Workplace Violence 101 regional training on July 18 in Galt and July 19 in Corning.



The Committee recessed for lunch at 11:28 a.m.

The meeting resumed at 11:50 a.m.

Laura Cole, President and Founder of ColePro Media, provided a presentation on "Having a Communication Strategy During a Crisis" where she covered the art of communicating, how to get your message out, the ins and outs of a successful media interview, tips for holding successful community meetings, and crisis communications.

Michael Young from City of Rocklin joined the training session.

Chief Allen Byers left the meeting at 12:05 p.m.

Ms. Cole indicated the appropriate time to release camera footage is within ten days, but show the video to the family first. She highly recommend to have a dedicated liaison that speaks between the family and the department.

### POLICE RISK MANAGEMENT GRANT FUNDS

#### **ACTION ITEM**

**ISSUE:** In the last five years, the Board has approved a total of \$250,000 in grant funds for Police Risk Management. The Grant Funds Historic Usage Report is included to ensure members are aware of the available grants for their agencies.

Funding for the grants has been approved for FY 19/20, though the Board has questions about the application for members without Body Worn Cameras that will be addressed at the meeting.

**RECOMMENDATION:** Provide feedback and recommendations regarding grant use.

**FISCAL IMPACT:** To be determined.

**BACKGROUND:** The Board approved a FY 14/15 budget of \$50,000 for the purchase of body cameras for NCCSIF's police agencies. The funds were initially used to purchase a total of 58 cameras directly from VieVu at a quantity discount. Two members used the funds to purchase different cameras and two have yet to take advantage of the funds. The FY 15/16 and FY 16/17 budgets of \$50,000 were allocated to the members to fund their body camera programs. If the body camera program is fully funded then member agencies have the option to use the funds for other safety and risk management uses such as data storage for body cameras, ballistic vests, and concealable vests with load bearing carriers. The FY 17/18 budget of \$50,000 and the FY 18/19 budget of \$50,000 were both allocated to the member police agencies for safety and risk management uses.

### LEGISLATIVE UPDATE

#### **INFORMATION ITEM**

**ISSUE:** The following bills were introduced in the California Legislature 2019-2020 Regular Session and if signed into law will affect police agencies:

### 1. Assembly Bill AB 392 - Weber. Peace officers: deadly force.

An act to amend Sections 196 and 835a of the Penal Code, relating to peace officers.

This bill would redefine the circumstances under which a homicide by a peace officer is deemed justifiable to include when the killing is in self-defense or the defense of another, consistent with the existing legal standard for self-defense, or when the killing is necessary to prevent the escape of a fleeing felon whose immediate apprehension is necessary to prevent death or serious injury. The bill would additionally bar the use of this defense if the peace officer acted in a criminally negligent manner that caused the death, including if the officer's criminally negligent actions created the necessity for the use of deadly force. This bill would also affirmatively prescribe the circumstances under which a peace officer is authorized to use deadly force to affect an arrest, to prevent escape or to overcome resistance.

### 2. Assembly Bill SB 230 - Caballero. Law enforcement: use of deadly force: training: policies.

An act to add Chapter 17.4 (commencing with Section 7286) to Division 7 of Title 1 of the Government Code, and to amend Section 196 of, and to add Section 13519.10 to, the Penal Code, relating to law enforcement.

This bill would require each law enforcement agency to maintain a policy that provides guidelines on the use of force, utilizing de-escalation techniques and other alternatives to force when feasible, specific guidelines for the application of deadly force, and factors for evaluating and reviewing all use of force incidents, among other things. The bill would require each agency to make their use of force policy accessible to the public. By imposing additional duties on local agencies, this bill would create a state-mandated local program.

This bill would revise the circumstances under which a homicide by a peace officer is justifiable to apply to those situations in which the officer reasonably believes the escape of the suspect poses an imminent threat of death or serious physical injury to the officer or others or when a fleeing suspect has committed a felony involving the infliction or threatened infliction of death or serious bodily harm. By changing the circumstances under which a peace officer may be charged and convicted of a homicide, this bill would impose a state-mandated local program.

This bill would require the commission to implement a course or courses of instruction for the regular and periodic training of law enforcement officers in the use of force. The bill would require the commission to develop uniform, minimum guidelines for adoption and promulgation by California law enforcement agencies for the use of force, as specified. The bill would encourage law enforcement agencies to adopt and promulgate a use of force policy and would state the intent of the Legislature that each law enforcement agency adopt, promulgate, and require regular and periodic training consistent with the agency's policy that complies with the guidelines developed under this bill.

This bill would make findings and declarations regarding the intent of the bill, as it pertains to law enforcement agencies' use of force polices, including that those policies may be introduced in legal proceedings and may be considered as a factor in determining the reasonableness of an officer's actions, but do not impose a legal duty on an officer to act in accordance with the policy.

### 3. Assembly Bill SB 542 – Stern. Workers' compensation.

An act to add Section 3212.15 to the Labor Code, relating to workers' compensation.

This bill would provide that in the case of certain state and local firefighting personnel and peace officers, the term "injury" also includes a mental health condition or mental disability that results in a diagnosis of post-traumatic stress or mental health disorder that develops or manifests itself during a period in which the firefighting member or peace officer is in the service of the department or unit. These provisions would apply to claims for benefits filed or pending on or after January 1, 2017.

**RECOMMENDATION:** Information only.

FISCAL IMPACT: None.

**BACKGROUND:** The Program Administrators continue to track the progress of these bills as they make their way through the legislative process. September 13th is the last day for each house to pass bills and October 13th for the Governor to sign or veto bills.

It weighs 10 pounds, is fully-collapsible, and fits into the trunk of a standard police cruiser.

And it just could end up saving the life of a San Joaquin County Sheriff's Deputy and the people they rush in to protect.

The Helus Shield – named after the Ventura County Sheriff's Department Sgt. who was killed when he rushed into an active shooter situation at a bar last November - is now a tool that local deputies will have at their disposal when responding to calls like the one that Ron Helus took last year at a bar in Thousand Oaks.

Helus, who gave his life in order to subdue an active shooter that ultimately killed 11 people, served as the inspiration for the creation of the shield which replaces traditional ballistic shields that are often clunky and rigid.

San Joaquin County Sheriff Pat Withrow has championed the use of the shields, which were designed in part by the department's range master, since before he took office and earlier this month announced the deployment of 20 of the \$600 pieces of equipment that he hopes will eventually be available to every sworn deputy on the force.
